b) Members who have cast their votes by remote e-voting prior to the AGM may participate in

c) Members holding shares either in physical or dematerialized form, as on cut-off date, i.e., Friday, November 22, 2024, may cast their votes electronically through remote e-voting before the AGM or e-voting at the AGM. The voting rights of members shall be proportionate to their share of the paid-up equity share capital of the Company as on the cut-off date, i.e.,
